WORK SESSION
DECEMBER 1, 2020**

I. There was a Work Session meeting of the Mayor and Council of the City of Cumming on Tuesday, December 1, 2020, at 6:00 P.M., at City Hall in Cumming, Georgia. The Mayor and all Council Members were properly notified as required by law and all were present. Mayor Troy Brumbalow presided over the meeting and called the meeting to order.

II. Invocation: Mayor Brumbalow asked Mr. Phil Higgins to deliver the invocation.

III. Pledge to the Flag. Mayor Brumbalow led everyone in the Pledge to the American Flag.

IV. Consider Agenda for Adoption- A motion was made by Chad Crane and seconded by Jason Evans to adopt the agenda as presented. The motion carried unanimously.

V. Consider for adoption the following meeting minutes: A. Regular Council Meeting of November 17, 2020: A motion was made by Chad Crane and seconded by Jason Evans to approve the minutes of the Regular Council Meeting of November 17, 2020 as presented. The motion carried unanimously.

B. Executive Session Meeting of November 17, 2020: A motion was made by Christopher Light and seconded by Joey Cochran to approve the minutes of the Executive Session Meeting of November 17, 2020 as presented. The motion carried unanimously.
