Reference: Distribution and Collection Division SHOP Flooring Project

SCOPE OF WORK

<u>Abrasive shot blast</u> approximately 27,000 square feet of concrete floor minus the office space area. Remove all surface contaminants and profile the surface to provide a mechanical adhesion of the epoxy floor coating system. The texture will resemble 24-36 grit sandpaper.

<u>Diamond- grind</u> the perimeter edges and recessed areas of the concrete surface to remove concrete laitance and promote a mechanical bond between the recommended 100% solids epoxy coating system manufactured by Thermal Chem. All tools will be vacuum shrouded for dust control.

<u>Work Scope area repairs</u> includes filling all concrete cracks and all concrete imperfections. Filling the control joints and expansion joints, running cracks, concrete defects is included. The area near the roll-up door represents approximately 800-1,000 square feet and is recessed ¼"-1" and needs filled to match the adjoining surface elevation. Mechanically abrade existing area and prime with 100% solids epoxy. Mix aggregate & 100% solids epoxy 8:1 ratio to fabricate a epoxy polymer concrete matrix. Apply by screed to repair affected area. Fabricate a slope-ramp 4'W X 10'L between building addition to create a sloping ramp across the entrance to transition between elevations.

Install selected flake or decorative system in the restrooms and other breakroom and meeting rooms, as specified by facility. See color selectors.

Thermal-Chem. Floor Coating System.

Apply system according to the manufactures Product Data Sheets for Armor-Prime #726 and Armor-Bond #731 Epoxy Coating in the selected color. The #726 primer will be applied at 150 square feet per gallon or approximately 10-12 mils dry film thickness. (DFT). The #731 Epoxy Finish Coat will be applied at 80 square feet per gallon or 20 mils DFT. The system thickness will be approximately 25-35 mils DFT. Broadcast and back-roll 36-60 grit white aluminum oxide into the finish coat to provide anti-slip characteristics, as agreed upon. Line striping is included within the work scope proposal. Facility to provide line striping details.

OWNER TO FURNISH

- Disposal location for concrete dust & waste sundries removed from work scope.
- Scheduled access to project location as agreed upon
- Work approval before de-mobilization for each phase of the project.
- 4 separate 115 VAC outlets at 20 amps each for grinders & vacuums.
- All materials are to be stored in climate-controlled environment.

CONTRACTOR TO FURNISH

All labor, (non-union labor utilized) equipment, materials, coatings, aggregates, concrete, sundries, required to complete scope of work.

General liability insurance 4.0 million aggregate.
